**HORSE REGISTRATION:** Pre-registration is required prior to parade day. **Proof of Insurance must be submitted with registration and release form before Saturday morning to parade chair.** Insurance must include bodily injury and property liability with combined single limit of \$1,000,000 (one million) dollars.

An adult must accompany all persons under the age of 9 at all times. All tack must be clean, in good repair and fit properly. Horses must be kept under control at all times or you will be asked to leave parade. Judging begins at 9:00 AM for horse entries. Horse entries will be judged in the east parking lot of the Middle School, and then proceed to place in line at 9:45 AM. Please keep off the grass.
